The following is a contract between Kessler Kennel Farms, LLC and the pet owner whose name and signature appears below. Please read and initial next to the following statements:

\_\_\_\_\_ All the dogs are provided with the same outside time. Dogs that are kept in either in their own separate area or in smaller playgroup will be intermittently monitored. We are unable to continually watch each individual pet the entire time they are out. There is always staff outside while the dogs are in the areas maintaining an overall surveillance. We will not assume responsibility for dogs eating rocks and or sticks. We do our best to keep these areas free of debris given our farm style environment.

\_\_\_\_\_ I have discussed with the kennel owner or an employee regarding my dog being let out to run in one of the pastures on the premises. I have been warned of the possibility of my pet escaping by either digging under or scaling over the fence. If I give permission to let my dog out to run, I agree not to hold Kessler Kennel Farms, LLC responsible for my pet escaping. I understand that efforts will be made by Kessler Kennels to retrieve my pet and the local authorities will be notified of the loose animal.

\_\_\_\_\_ I represent my dog(s) as being in good health, currently vaccinated, and free from any communicable diseases.

\_\_\_\_\_ I have provided copies of current rabies, canine influenza (H3N2 or bivalent), and Bordetella vaccines.

\_\_\_\_\_ I represent my dog(s) as non-aggressive or harmful to people. Any aggressive tendencies MUST be explained prior to service. I am responsible for informing Kessler Kennel Farms, LLC of any and all abnormal behaviors to be aware of, such as sensitive areas to the touch, food aggression, separation anxiety, etc. I agree to pay all costs for any property damage or personal injury caused by my pet during its stay.

\_\_\_\_\_ I allow Kessler Kennel Farms, LLC to take and post photos & videos of my pet(s) while boarding or attending daycare.

\_\_\_\_\_ I hereby grant permission to Kessler Kennel Farms, LLC to act on my behalf, and in my pet's best interest, by obtaining veterinary care at my expense, if deemed necessary, for illness or injury. I further agree to pay for all veterinary and other necessary services incurred by and for my pet during its stay at this facility.

\_\_\_\_\_ Kessler Kennel Farms, LLC agrees to exercise all due and responsible care to prevent injury or illness to my pet. However, in the event of illness or injury, the kennel owner, and employees of this boarding facility, shall not be held personally liable for such illness or injury.

\_\_\_\_\_ I agree to pay all charges on the day of drop-off of my pet. I understand that my pet may not leave the premises until all charges are paid in full. The current rate for boarding is \$48.00 per day/per dog/tax incl occupying one kennel. I understand that any pet left for 10 days beyond the agreed date of pick-up, may be sold, or disposed of at the discretion of the kennel owner. Multiple occupancy rates available upon request.
